**Seasonal - \$125.00** Business open less than 6 months during the year. Less than 10 employees.

**Second Business - \$125.00** Same ownership under a second business with less than 10 employees.

#### Other organizations/non-profits/government/schools:

**Agriculture** (growers, dairy/livestock producers, active family farming): **\$165.00** if less than 10 employees. Use above schedule if over 10 employees.

Financial Institutions: \$6.00 per million of deposits in Somerset County. (\$500 minimum) Utilities: See above schedule (\$400 minimum)

**Government/Municipalities: \$205.00** if less than 10 employees. Use above schedule if over 10 employees. **Public School Systems: \$150.00** (elementary/high school)

Secondary Education: \$275.00 (Colleges, Universities)

Service Clubs/Non-Profit Organizations: \$150.00 if less than 10 employees. Use above schedule if over 10 employees.

**Friends of the Chamber: \$55.00** - for non-business individuals or families that want to stay connected to the business community and have an active role in advancing the county.

**Note:** An employee is defined to be what the company considers to be a "full-time" employee or a full-time equivalent. *If your company has part-time employees, take the total hours they worked in the past year and divide by 2,080 to get the full-time equivalent; then add to the number of full-time employees.* Employee includes exclusive independent contractors such as real estate agent, insurance agent, etc.
